A. Overview

D. What data we collect

Examples of information we may collect includes:

- the type, version, brand, language and operating system of device.
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- behavioral usage of the App.
- email address.
- the type and operator of network (such as Mac address).

E. How we use your data

We use your data to:

- improve, support and administer the App.
- allow you to use the App's functionalities.
- understand how you use the App, including across your devices.

- promote the safety and security of the App.
- train and improve our technology.
- comply with applicable law.

F. How we share your data

We do not sell your personal data. We share your data with the third parties stated below:

- service providers and business partners to help us perform business operations and for business purposes, including research and database maintenance.
- entities within our corporate group to provide certain important functions of the App.
- to respond to subpoenas, court orders, legal process, law enforcement requests, legal claims, or government inquiries.

G. Your rights

The privacy rights you may have are the following rights to:

- Request access to and portability of your personal data about you.
- Request deletion of your personal data.
- Request correction of your personal data where it is inaccurate or incomplete.
- Withdraw your consent to our processing of your personal data.

H. Children

The App is intended for general audiences. We do not seek through our App to gather personal data from or about persons that are 13 years of age or younger ("children"). If you inform us or we otherwise become aware that we have unintentionally received personal from children, we will delete this data from our records.

I. Retention of your data

Our practice is to retain your personal data only for as long as necessary to provide our Services to you. When we have no ongoing legitimate business

need to process your personal data, our policy is to delete or de-identify the data.

J. Security of your data

We are committed to securing your personal information. Some of the ways in which we protect your personal data include:

- We encrypt your personal data when it is stored at rest.
- We protect your personal data with encryption during transmission over the public Internet.
- We use reasonable organizational and technical safeguards designed to help protect the privacy and security of your personal data.
